- Rachel Gallop reported that next Saturday, February 4, 2-5 pm, the Salvation Army will be holding the Souper Bowl Fundraiser
- Scott Blazek asked that the Gay Pride Parade in Clovis be put on the agenda for next month's meeting. Scott will find out what plans the City has with regard to the Parade, and report to next month's meeting.
- Patricia Bazar, Richard and Geri Gomez, and Steve Reshetar reported on the fire at the Clovis Apartments yesterday. Many organizations were on the scene with immediate help, including La Casa, the Lighthouse, Matt 25, the Red Cross, United Way, WIC. 12 families lost their homes and all their possessions. They were provided with food, clothing, and temporary lodging in a motel. There will be a long-term need to find financing for places to stay, housing, furniture, household goods, medical supplies, and to replace personal items. The agencies are meeting again at 1:30 today at the Lighthouse to plan effective ways of helping. At the moment the main need is for money. United Way is coordinating the help, and will act as the fiscal agent with a separate account for the finances. United Way can be reached by dialing 2-1-1. Financial offering from Churches should be sent to United Way. The meeting this afternoon will make a Bulletin Insert for distribution to the churches.
